MINUTES FROM DSNA GENERAL MEMBERSHIP Meeting of July 21, 2008

I. Call to order, sign-in, approval of minutes, and treasurer's report. Motion to approve minutes from June approved unanimously. **\$2,241 in account.** \$700 approved for plaque for crossroads sign, \$100 for paint for bulletin board (not spent yet), \$200 donation from Ward 1 office for neighborhood block party in October.

II. Announcements – none.

III. Discussion

Stop Signs on University Bike Route

Ward 1 has talked with Ian about the idea of changing the 4-way stops at University and 9th Ave and University and 10th Ave to 4-way yields. Reality is bikes roll through signs, and we are requesting a change from the city. Other parts of the country have 4-way yields. This exists in West University at 7th Ave and 4th St. •Why not have them all the way through the neighborhood at traffic circles, especially all down 9th Ave?

•Get input from West University neighborhood near the 4-way yield.

•West University traffic circle is much bigger and streets are wider so cars are going faster there.

•Most cars will yield to bikes at these intersections.

•Idea of bike exempt sign? Seems like there will be strong resistance.

•Board members will talk with West University and get more feedback from the neighborhood.

Motion to propose 4-way yields at 9th and 10th Ave and University and get feedback from neighborhood and others and come back next month. Approved with 1 abstention.

Neighborhood Reinvestment Grant

Lori Aledcoa from Pima County is targeting the October bond committee meeting, so we have a few more months to bring this grant together. Jonathan Crowe passed around maps with traffic calming, street beautification, and water harvesting enhancements noted. For the water-harvesting pull-outs, the curb is rebuilt and pulled into the street a bit. This narrows the road so cars slow down as well as harvest water from rainstorms. The speed humps would have water-harvesting pull-outs on either side. There would be benches for public gathering spaces as well. The list of projects needs to be brought to the city for cost estimates.

•Water-harvesting pull-outs will have trees/shrubs planted in them. Chicanes are the formal name for these pull-outs.

•Need pedestrian crossing for railroad on Main. There are federal regulations on how this looks. It should tie in to existing sidewalks and crosswalks.

•Question about impact of additional 3rd rail line.

•ADA ramps on corners of curbs.

•Should there be a traffic circle at 1st Street and 10th Ave? •More sidewalks?

•More sidewalks?

•If there is a speed hump near a proposed traffic circle, we must pay for removal of speed hump.

Some areas will have angle parking (helps narrow the street).
What about building traffic circles lower to ground for water flow? On 1st St a flush circle would get scoured in a storm.
How far away is water coming when it goes down 1st St? From the entire university area.

•Why doesn't 1st St have a lot of water-harvesting pull-outs? •Turtle and Jeff and Natasha said they would help with the grant.

Acquisition of Queen Ave by Islamic Mosque

City Department of Real Estate sent a letter for sale of the alley between 11th and Queen north of Speedway up to Helen. The mosque would like to purchase this alley for safety purposes.

Downtown Links – next steps

Alignment 3-D was approved by the CAC on June 23 with a vote of 11-3. It was approved by Mayor and Council on July 8 by 6-0. Now it is in the design phase.

•Questions about federal money allocated in 2005 to deal with railroad crossings at 22nd, 9th Ave and 6th St, and Speedway. If using federal money, there are more stringent guidelines.

•In June, neighborhood asked for a series of mitigation projects if 3-D was approved. Letter delivered to Mayor and Council, CAC, and transportation department.

•Next CAC meeting is August 11th at 5:30 in main library's lower level meeting room.

•Question about how deck will work and whether road needs to start slope further back. Drawing shows deck being as wide as area of proposed railroad park.

•Nina Trasoff e-mail indicated road would be for moving traffic around downtown.

•Mileage will be signed for 30 mph.

•A subcommittee is forming to look at 3-D proposal and be a conduit for board and Ward 1 office. Committee needs a chair to call a meeting and get started.

•Concern about how neighborhood will communicate with Ward 1 office. In past, we were not overruled by Ward 1 office, especially where neighborhood is unified. Need to figure out what we should bother to get involved with vs. what we will get overruled on.

•Neighborhood relationship with Ward 1 office is shattered. If there is a hope for healing, board should meet with Regina. It would be nice if she initiated the meeting.

•From Diana R. (Ward 1 aide): Regina respects neighborhoods and wants them to be active, but she will make final decisions. She says this to all neighborhoods, not just ours.

•Regina could have voted with us and be the only no vote.

•Regina owes an explanation to neighborhood for her actions. It was a slap in the face for her to 2nd the motion to approve for the 3-D proposal.
