OLD BUSINESS

Liquor license at for Shell at Speedway and Main was denied by City, but now request moves to State Board; Shell replaced lawyer to request for an OOH hearing to be decided by a judge, who will make a recommendation to the Liquor Board. Eight people showed up to present reasons for denying license (everyone impressed by so much active support), now pushed to first Thursday in June. Officer Julsing will contact Salvation Army for their support. Community Food Bank (Caridad Kitchen) does not want to submit a letter. b. Moved, seconded to vote, and voted to vote (9-0); Moved, seconded and voted to write letter requesting Police Department to write letter on our behalf (vote 9-0)

c. Moved, seconded and voted that Sky Jacobs be reimbursed \$48.51 for three years of domain website. (9-0)

VISITING POLICE OFFICERS

Natasha brought up issue concerning dog at large (unleashed) who has bitten a neighbor. Officer suggested having PAC get involved and take pictures. PAC can support homeless owner with resources.

Officer Julsing said that we should report property crimes and suspicious activity online (or go into station) because of understaffing and added workload. It will add to data and help address circumstance,s although it might take some time to address it. Trespassing is a more serious crime.

There was a question if closing Santa Rita Park would affect houseless population in our neighborhood. The law is that no one can camp overnight at parks. The City is trying to provide more housing for over 65 and those with mental needs. Community Safety and Wellness tries to do three weeks of outreach before parks get closed.

Officer Julsing runs downtown district, so he will get involved in issues in Sector 8. They are doing a lot of good work, such as trying to close Congress Street at night for pedestrians only; they have cameras and a lot of good stuff, in play to address crime concerns. Captain Petty is very hard-working, and this neighborhood has the highest ratio of officers in the City. We have gotten a lot of people into housing, and we are working hard on more.
